5.	No interim correspondence shall be entertained & canvassing in any form will be a disqualification.
6.	Separate applications Form and Fee are required for each post in case candidates intending to apply for

A relaxation of 5% may be provided at the Graduate and Masters level for the SC/ST/Differently-abled (physically and visually differently-abled)/Other Backward Classes (OBC) (Non-creamy layer) categories for the purpose of eligibility and for assessing good academic records for reserved category post during direct recruitment to teaching positions. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark procedures.
13.	Person suffering from not less than 40% of the relevant disability shall alone be eligible for the benefit of reservation for Person with Disabilities.
14.	Candidates applying/availing the benefits of SC/ST/OBC/EWS/PwD must submit valid certificate in the prescribed proforma applicable for appointment to the posts of Central Government.
15.	The University reserves the right to increase/decrease the number of posts and accept or reject application(s) without assigning any reasons. Further, the decision of the Screening Committee/Selection Committee/Executive Council shall be binding on all the candidates
16.	The Selection Committee may decide its own method of evaluating the performance of the Candidates.
17.	The rules of UGC/Govt. of India in regard to Pay and Allowances, Leave, Pension & Provident Fund shall be followed subject to amendments if any, from time to time. New entrants shall be covered by the National Pension Scheme (NPS).
18.	The selected candidates for appointment shall have to serve the University at least for a minimum period of 3 (three) years from the date of joining. During the period of 3 (three) years his/her application shall not be forwarded for outside employment.
